7. Contextual Paragraph	Colorado courthouses are prominent and important buildings throughout the state, and play an important role in the establishment of the communities they serve. Many times, courthouses were the signs and symbols of the government of the town, state, or nation in a place that may seem somewhat lawless otherwise.
	The Hinsdale County Courthouse in Lake City may seem like a demure building, but it has always been on the stage as an important one because of its role in county government and events. Examples include events such as when Alfred Packer was on trial in the courthouse, and when Susan B. Anthony packed the courthouse to speak to miners encouraging them to allow women to vote. It still functions as an important building in the region, and was definitely more advanced in design than most buildings in the community built during the same period. It has elements from the Italianate style (paired gable-end brackets, narrow thin windows with pedimented window heads, etc) and is one and a ½ story tall which is larger than other common buildings in the town.
8. Connection to Historic Preservation	The Colorado State Historical Fund has invested millions of dollars in the restoration and preservation of historic sites in the state of Colorado and courthouses are some of their most widely seen and visited investments across the state. From roof to foundation, wood to stone, the materials, finishes, and built structures of these important buildings showcase what is best about Colorado craftsmanship. Many are landmarked and placed in the local, state, and national registers. The Hinsdale County Courthouse is part of the Lake City









Historic District, which was placed in the National Register of Historic Places in 1978. It's a	
contributing building because of its architecture and events which occurred there.


